We would like to extend this special invitation to all outdoor cooks to come to Stillwater, April 6<sup>th</sup> & 7<sup>th</sup>, 2012, for the Stillwater Elks 24<sup>th</sup> Annual BLAZATHON COOK-OFF. This Cook-Off is sanctioned by the Kansas City Barbecue Society.

The Cook-Off is designed to raise funds for Judith Karman Hospice. It will be a place to compare cookers, cooks, and techniques. The cooked foods will be donated to the Stillwater Elks Lodge No. 1859, to be served with the meal on Saturday, April 7<sup>th</sup>, 2012. A portion of the proceeds, after reasonable expenses, will be donated to Judith Karman Hospice.

Kansas City Barbecue Society rules and regulations will be used. Be sure to note the changes in this year's rules and regulations. The grounds will open at noon on Friday the 6<sup>th</sup> of April. A cook's dinner will be held at 6 p.m. followed by a Cook's Meeting at 7:00 p.m. on Friday, April 6<sup>th</sup>.

"ANYTHING BUT" Contest on Friday, Entry turn in will be at 9:00 p.m. Friday for the "Anything But" Contest. Other entry turn in times will be Saturday, April 7<sup>th</sup> at:

10:30 a.m. for both Jackpots;

11:00 a.m. for Chicken;

11:30 a.m. for Pork Ribs;

12:00 noon for Pork Shoulder or Boston Butt;

12:30 p.m. for Beef Brisket.

Cookers will be regulated to a 20' x 30' spot, with at the most, one vehicle per cook team per spot. There will be no vehicle movement in the cooking area on Friday between the hours of 8:30 p.m. and 6:00 a.m., (except for late cooker arrivals), and on Saturday from 8:30 a.m. until 2:00 p.m.

Prizes will be awarded on Saturday, April 7<sup>th</sup>, at approximately 3:00 p.m.

Prizes will be awarded as follows:

Grand Champion: \$2,000.00

Reserve Grand Champion: \$1,250.00

Each Category; Poultry, Ribs, Pork, and Brisket:

1st Place - Ribbon and \$175.00 cash.

2nd Place - Ribbon and \$125.00 cash.

3rd Place - Ribbon and \$75.00 cash.

4th Place - Ribbon and \$50.00 cash.

5th through 10th Place - Ribbon and \$25.00 cash.

In addition to the cook off there will be JACKPOT CONTESTS for BEANS and for SAUCE. Entry fee will be \$10 for each jackpot. Winner will receive 1/2 (one half) the pot and a nice trophy.

Additional rules and/or other changes will be discussed at the Cook's Meeting on Friday April 6<sup>th</sup>, at 7 p.m.

**“ANYTHING BUT” RULES**

Anyone competing in the KCBS Sanctioned Blazathon Cook-Off  
is invited to compete in the “Anything But” Contest  
Friday Night, April 6<sup>th</sup>, 2012.  
Cook’s meeting at 7 pm  
“Anything But” turn in at 9 pm  
Entry Fee \$20.00 per item

“Anything But” is defined at the Blazathon Cook-Off Contest to include any meat OTHER than any of the four KCBS judged categories to be held on Saturday. **NO DESSERTS!**

To further clarify:

- “Anything But” Chicken. Other poultry such as duck, turkey, etc. is acceptable.
- “Anything But” Spare Ribs, Loin Back Ribs. Country Ribs are acceptable.
- “Anything But” Pork Shoulder, Boston Butts. Other parts of the pig are acceptable.
- “Anything But” Beef Brisket. Any other part of the cow is acceptable.
- “Anything But” Dessert.

Recipe may be:

- Marinated or injected, and this may be done before arrival;
- Baked, broiled, barbequed, grilled, fried, etc...;
- Garnishes. Garnish is anything that is not essential to the taste of the finished dish;
- Served as a salad, hors d’oeuvre, casserole, etc...

Generally, anything goes. No Holds Barred in the preparation of “Anything But”.  
Gas grills are allowed for “Anything But” Contest.

Entrants must be competing in the Blazathon Cook-Off Contest.  
The “Anything But” entry must be the work of an individual team.

Judging will be a modified KCBS format.  
Judging will be Friday Night using the “Blind Judging” technique.

The Contest Organizer will provide numbered 9 x 9 Styrofoam containers to turn in your entry.

- Prizes will be:
- 1<sup>st</sup> Place 40% of entry fees for “Anything But” Contest.
  - 2<sup>nd</sup> Place 20% of entry fees for “Anything But” Contest.
  - 3<sup>rd</sup> Place 15% of entry fees for “Anything But” Contest.

Prizes will be awarded on Saturday with the prizes of the Blazathon Cook-Off Contest.

**Entry Fee is \$20.00 for the “ANYTHING But” Contest.**

**SAUCE JACKPOT CONTEST**

**In conjunction with the cook-off there will be a SAUCE JACKPOT contest.**

**The same rules will apply as the cook-off with a couple of additions.**

**The Entrant must be entered in the Blazathon Contest.**

**The contestants must be willing to eat their own SAUCE.**

**Will need to furnish the six- (6) judges with approximately 12 ounces.**

**Will be judged at 10:30 a.m.**

**Will be judged on appearance, taste, aroma, and texture.**

**Entry Fee is \$10.00 for the SAUCE JACKPOT.**

**BEAN JACKPOT CONTEST**

**In conjunction with the cook-off there will be a BEAN JACKPOT contest.**

**The same rules will apply as the cook-off with a couple of additions.**

**The Entrant must be entered in the Blazathon Contest.**

**The contestants must be willing to eat their own BEANS.**

**Will need to furnish the six- (6) judges with approximately 12 ounces.**

**Will be judged at 10:30 a.m.**

**Will be judged on appearance, taste, aroma, and texture.**

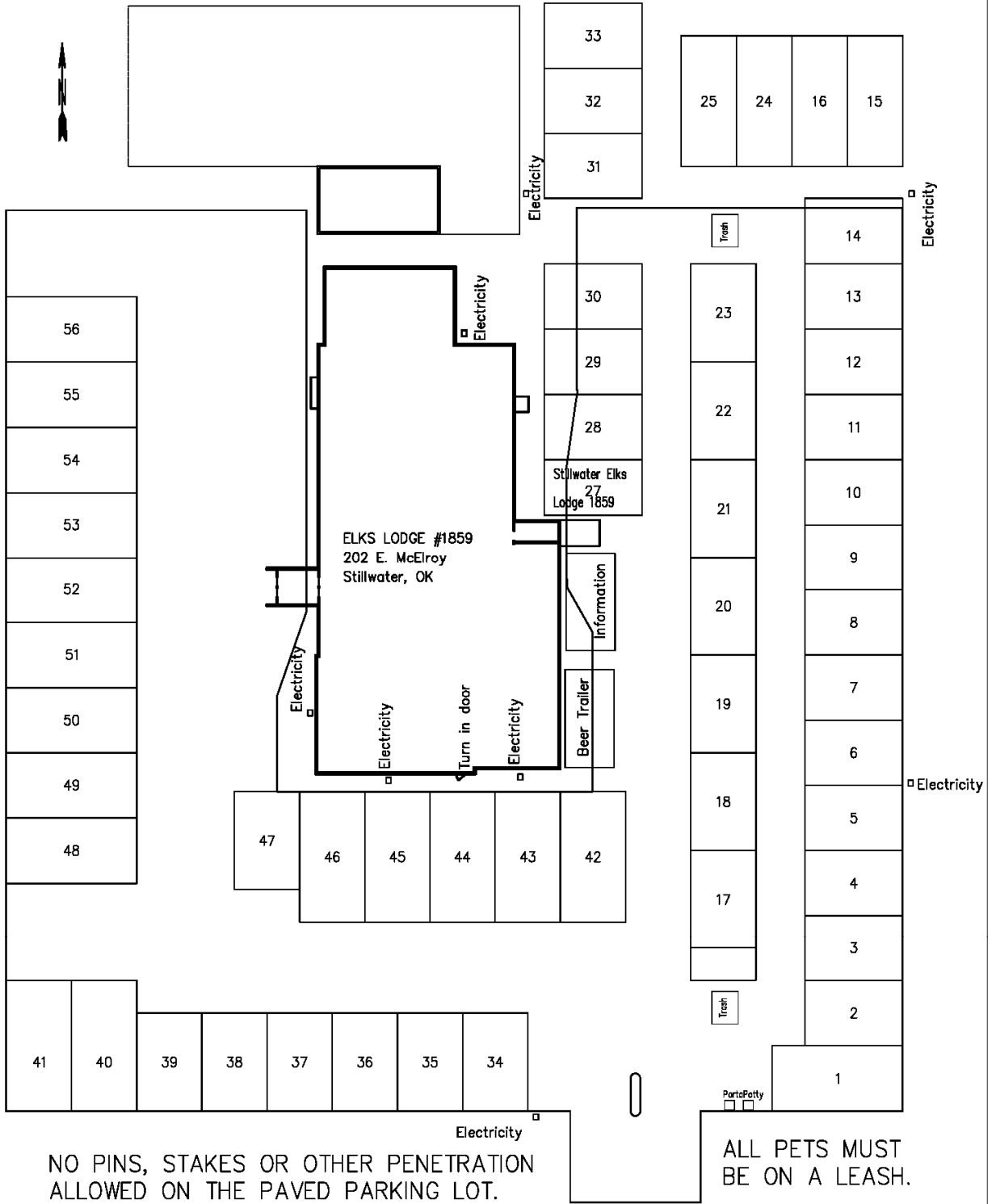
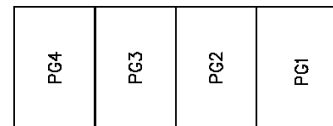
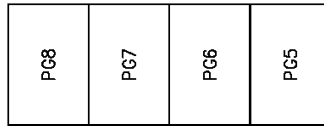
